SAN DIEGO: San Diego County is home to more than 3.3 million people spread across 18 cities. The region is consistently recognized as a top life sciences market with an established tech scene, supported by distinguished universities and unrivaled quality of life. San Diego is part of a larger binational region that encompasses San Diego County, Imperial County and Baja California, Mexico. With a combined population of more than 7.1 million people, a 27,000 square mile footprint, two international airports and the busiest land port of entry in the western hemisphere, our binational identity offers unique business and lifestyle opportunities.

In 2018, California surpassed the United Kingdom as the fifth largest economy on the planet. Helping drive this economic powerhouse, San Diego's gross domestic product is the fourth largest in California totaling \$231 billion. If we were our own state, San Diego would rank as the 26th largest economy in the country. San Diego's economy – combined with the region's diverse communities, population and global connectivity – supports the attraction and retention of top talent and some of the world's most innovative companies.

San Diego's economy is made up of three major pillars: innovation, driven by our region's educated, energetic and talented workforce; tourism, built upon our region's coastal geography and rich culture; and defense, including the largest concentration of military assets in the world. Talent is the heart of San Diego's economic engine. Our broader innovation economy sits on a foundation of established industries, including life sciences, information and communication technologies and aerospace. Over the last decade, the intellectual capital generated across these pillars has accelerated growth in cybersecurity, software development, biotech and clean energy. More recently, this diverse set of core competencies has propelled growth in burgeoning industries that include unmanned systems, robotics, machine learning, 3D printing, genomics, precision medicine, IoT and more. Stimulating endless opportunities for converging research and technology across industries, San Diego's innovation economy plays a crucial role in the success of our ecosystem.


GLOBAL CONNECTIVITY

San Diego's location on the West Coast and proximity to the Mexican border provides an attractive geographic position to expand trade with the Pacific Rim. Contributing to San Diego's global connectivity are the mega region's two international airports, offering direct access to global centers like London, Tokyo, Shanghai, Frankfurt and Zurich. Increasing ease of access to our neighbors across the border, the end of 2015 brought with it the completion of the world's first cross-border airport terminal between San Diego and Tijuana.

SAN DIEGO:

BUSINESS INCENTIVES AND SUPPORT

San Diego benefits from strong partnerships between government and business, and a uniquely collaborative political environment that provides stability for our growing local economy. Mayor Kevin Faulconer has worked to streamline the permitting process at the City, provide incentives for major investment, and promote San Diego's regional economy on a global scale. San Diego's County Board of Supervisors have won national awards for fiscal stewardship and stability, and our state and federal representatives work collaboratively across party lines in order to support San Diego's businesses and economy. Incentives at the local, state, and federal level offer cost saving opportunities for your expansion into San Diego. EDC has worked with a variety of multinational companies across San Diego County in securing these tax credits.

LOCAL INCENTIVES

City of San Diego - Business Incentive Program

In exchange for the City's financial or dedicated technical assistance offered to a business for the purpose of incentivizing business activity aimed at furthering one or more of the stated goals (incentives), a business must commit to a minimum investment and/or job creation over a defined period of time. Further, the desired outcome of this Council Policy is the creation and retention of quality jobs and capital investments across San Diego, with a particular emphasis in low- and moderate-income communities. Companies who meet the minimum program requirements will be awarded \$10,000 with maximum incentives up to \$100,000.

CALIFORNIA STATE INCENTIVES

Tax Credits

California Competes tax credit is an income tax credit available to businesses with plans to grow in California. Companies outline planned investments and additional full-time hires over a five-year period and enter an agreement with the state which awards credits annually as growth milestones are achieved. Application periods for the FY 2018-19 program are as follows:

- July 30, 2018, through August 20, 2018 (\$70 million available)
- January 2, 2019, through January 21, 2019 (\$75 million available)
- March 4, 2019, through March, 25, 2019 (Any remaining unallocated amounts from the previous application periods)

Research and Development Tax Credit is an up to 15 percent credit for qualified in-house research expenses and a 24 percent credit for basic research payments to an outside organization, offered to companies that conduct qualified research activities in California. A federal research credit is also available.

Manufacturing and R&D Equipment Exemption is available to manufacturers and certain research and developers. Companies may qualify for a partial exemption of sales and use tax on certain manufacturing and research and development equipment purchases and leases. Qualified companies will pay only 3.3125 percent sales or use tax until 2022 on qualifying purchases and leases. Qualifying purchases are limited to \$200 million in a calendar year.

FEDERAL INCENTIVES

Trade Incentives

Foreign Trade Zones are federally designated areas where companies can delay or reduce duty payments on foreign merchandise. San Diego has one FTZ in the City of San Diego (No. 153).

Interest Charge Domestic International Sales Corporation Return (IC-DISC) is a federal tax incentive for exporters of products made in the U.S. California manufacturers who receive 50 percent of their net income from foreign sales may be subject to a significantly reduced US income tax rate.

Export-Import Bank finances the export of U.S. goods and services to international markets by providing working capital guarantees (pre-export financing); export credit insurance; and loan guarantees and direct loans.

Financing

EB-5 Financing provides foreign nationals the opportunity to become conditional residents for a period of two years upon making an investment of \$1 million, or \$500,000 in a designated Targeted Employment Area, in a new commercial enterprise. Each unit of investment must create at least ten new, direct or indirect jobs for U.S. workers

Workforce Development

Work Opportunity Tax Credit is available to employers for hiring individuals from certain target groups that have consistently faced significant barriers to employment.

Tax Credits

New Markets Tax Credit program awards companies a tax credit against their Federal income in exchange for making equity investments in specialized financial institutions called Community Development Entities (CDEs).
